

## Daycare and Facility Use Agreement InBark, LLC

- 1. I understand and agree that InBark, LLC (herein after referred to as InBark) and its members, officers, directors, managers, employees, contractors and agents will not be liable for problems, damages or injuries caused by my pet during its visit at InBark. I, as the pet owner (or as the pet's authorized agent), agree to be solely responsible for any and all acts or behavior of my pet while in the care of InBark. I hereby release and agree to indemnify and hold harmless InBark from any liability arising from my dog's attendance and participation in any InBark daycare and/or park play sessions.
- 2. I understand that InBark daycare and open play areas are places where animals co-mingle in groups. I recognize that there are inherent risks of illness or injury when dealing with animals. Similarly, I understand that when dogs play in groups, they may sustain injuries such as nicks and scratches. I understand and agree that any problem or injury that develops with my dog will be treated as InBark deems best at its sole and absolute discretion. InBark staff may wait until I pick up my pet to inform me of any non-serious injury, such as nicks and scratches. In the event my pet becomes ill or injured to the point of requiring medical treatment, InBark will first attempt to contact me, followed by an attempt to contact the emergency contact listed on the enrollment form. If the circumstances are deemed, at its sole and absolute discretion, such that immediate treatment is necessary, InBark may attempt to contact my pet's veterinarian. In the event my pet's veterinarian is not available, a veterinarian will be chosen by InBark. InBark retains sole discretion to deal with emergency matters and I agree to promptly pay for all medical treatments received by my pet, including transportation to an emergency veterinary facility.
- 3. I understand that InBark will not accept any unaltered dogs over the age of 6 months, with absolutely no exceptions. Any misrepresentation of my dog's spay or neuter status will result in immediate removal of my pet from the facility, and will also subject me to an inconvenience fee of \$100. I also understand that all dogs must be current on the following vaccinations: Rabies, DHLPP, and Bordatella. Proof of all vaccinations must be provided to InBark.
- 4. I understand that I am responsible for any harm caused by my dog at InBark, whether to dogs or human patrons or to InBark staff, I shall indemnify and hold InBark harmless against any claims made against InBark or losses or damages of any kind suffered by InBark as a result of my pet, its behavior or condition or my failure to inform InBark of any pre-existing condition my pet may have (such as illness or aggressive tendencies). I understand and agree that, in admitting my dog to InBark, InBark's staff has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog.
